CANNOT CARRY OUT A VALID INSTRUCTION. I FIND OUR GOVERNMENT'S POSITION ON LANDMINES INDEFENSIBLE, FILLED WITH CONTRADICTIONS, AND INCONSISTENT WITH TRUE U.S. NATIONAL SECURITY AND FOREIGN POLICY INTERESTS.

2. (C) THIS IS A DEEPLY PERSONAL VIEW. I RECOGNIZE THAT THE U.S. POSITION WAS DEVELOPED BY CONSCIENTIOUS PEOPLE OF GOOD WILL AND HUMANITARIAN SPIRIT. STILL, A LARGE PART OF MY REASON FOR COMING TO ANGOLA RELATES TO ELIMINATING LANDMINES. IN DECEMBER 1994, I ACCOMPANIED TONY LAKE TO ANGOLA, FOUR WEEKS AFTER THE SIGNING OF THE LUSAKA PEACE ACCORDS. WE SAW THE VAST DEVASTATION OF WAR, INCLUDING THOUSANDS OF AMPUTEES FROM LANDMINE ACCIDENTS. AT A HOSPITAL IN THE DESTROYED CITY OF KUITO, WE SAW A PREGNANT WOMAN WHO HAD VENTURED INTO A MINEFIELD TO GET FOOD FOR CONFIDENTIAL

DEBATE OF THE SPECIFICS OF U.S. POLICY. I WOULD ONLY POINT OUT THAT THE USG INSISTENCE ON EXCEPTIONS FOR KOREA, ANTI-TANK MINES, AND OXYMORONIC "SMART MINES"; THE LABORIOUS CONDITIONS FOR U.S. ADHERENCE TO A TREATY; AND SEVERAL OTHER SIGNS OF WEAK USG RESOLVE OPEN THE DOOR BROADLY FOR OTHER COUNTRIES TO MAKE SIMILAR EXCEPTIONS AND THUS UNDERCUT THE WHOLE PROCESS.
