Appellants David Rowan, Donald Guyatt, Robert Rasbury, Ruth
Demeter, and Daniel Cooper respectfully move the Court for an order
expediting the briefing and consideration of this election contest
concerning the qualification of Marjorie Taylor Greene to be a candidate
for United States Representative from Georgia's Fourteenth
Congressional District.

"Statutes providing for election contests are premised on the recognition that election-related appeals must be timely considered." *McCreary v. Martin*, 281 Ga. 668, 670 (2007). As a result, the party challenging an election has a "duty to act with dispatch." *Id. See generally Schmitz v. Barron*, 312 Ga. 523, 524-25 (2021) (discussing the

importance of handling election contests on an expedited basis). And this Court frequently grants motions to expedite. *See Payne v. Chatman*, 267 Ga. 873, 875 (1997 ("motions for expedited consideration of election appeals have been granted by this Court to assure that a challenge to an election result is considered in a timely manner").

The appellants have acted with dispatch so far, and a decision is needed prior to certification of the November general election.

Accordingly, the Court should grant the appellants' motion to expedite, order an accelerated briefing schedule, and decide this case quickly on its merits.
