CLIFFORD ROBERT, an attorney duly admitted to practice law before the Courts of the State of New York, hereby affirms the following statements to be true under the penalties of perjury:

1. I am the principal of the law firm of Robert & Robert PLLC, attorneys for Defendants Donald Trump, Jr., Eric Trump, The Donald J. Trump Revocable Trust, DJT Holdings LLC, DJT Holdings Managing Member, Trump Endeavor 12 LLC, 401 North Wabash Venture LLC, Trump Old Post Office LLC, 40 Wall Street LLC, and Seven Springs LLC. I am fully familiar with the facts and circumstances set forth herein based on the files and materials maintained by my firm.

- 2. This Affirmation of Urgency is submitted in support of the Verified Joint Article 78 Petition brought by Order to Show Cause of Defendants Donald J. Trump, Donald Trump, Jr., Eric Trump, Allen Weisselberg, Jeffrey McConney, The Donald J. Trump Revocable Trust, The Trump Organization, Inc., The Trump Organization, LLC, DJT Holdings LLC, DJT Holdings Managing Member, Trump Endeavor 12 LLC, 401 North Wabash Venture LLC, Trump Old Post Office LLC, 40 Wall Street LLC, and Seven Springs LLC (collectively, "Petitioners") for an Order: (a) on the first cause of action, annulling and vacating Supreme Court's summary findings of contempt as in violation of lawful procedure pursuant to CPLR § 7803(3); (b) on the second cause of action, annulling and vacating Supreme Court's summary findings of contempt as in excess of Supreme Court's jurisdiction pursuant to CPLR § 7803(2); (c) on the third cause of action, finding that Supreme Court's gag order entered on the record on October 3, 2023, and soordered on October 26, 2023, is in excess of Supreme Court's jurisdiction under CPLR § 7803(2); (d) on the fourth cause of action, finding that Supreme Court's gag order entered on November 3, 2023, is in excess of Supreme Court's jurisdiction under CPLR § 7803(2); and (e) granting such further and additional relief as the court deems just and proper (the "Petition").
- 4. This Affirmation of Urgency is also submitted in support of Petitioners' request for a stay of enforcement of the above-referenced gag orders pursuant to CPLR § 7805 during the pendency of this proceeding.
- 5. The urgency of this application is evident, given that (1) the gag orders currently preclude Petitioners from posting, emailing, or speaking publicly about any members of Justice Engoron's staff, in contravention of the First Amendment of the United States Constitution and Article I, Section 8 of the New York Constitution; (2) the gag orders currently preclude Petitioners' counsel from making any public statements, in or out of court, that refer to any

confidential communications in any form between Justice Engoron and his staff, in contravention

of the First Amendment of the United States Constitution, Article L Section 8 of the New York

Constitution, and the absolute privilege attaching to in-court statements by counsel; and (3)

Justice Engoron's imposition of summary punishment exceeds his jurisdiction, violates the

Judiciary Law and the Rules of this Court, and constitutes an arbitrary and capricious exercise of

Justice Engoron's contempt powers. Petitioners' injuries are exacerbated by the ongoing and

public nature of the foregoing violations during a bench trial that is estimated to conclude over a

month from now.

5. On November 15, 2023, pursuant to 22 N.Y.C.R.R.§ 1250.4(b)(2), my partner

Mike Farina notified Respondents The Honorable Arthur F. Engoron, J.S.C., and People of the

State of New York, by Letitia James, Attorney General of the State of New York, via e-mail, of
