
- (a) pursuant to CPLR § 2507, justifying Knight Specialty Insurance Company (“KSIC”) as surety on the undertaking, upon the ground that said surety is duly qualified to act as such;
- (b) pursuant CPLR § 2506, setting aside the Notice of Exception to Surety as filed by Plaintiff on April 4, 2024;
- (c) pursuant CPLR § 2506, granting the costs incurred by this application, upon the ground that the exception has been taken unnecessarily and for vexation; and
- (d) granting such other and further relief as this Court deems just and proper; and it is further

ORDERED that opposition papers, if any, are to be served on Defendants’ and KSIC’s counsel via e-filing on or before the 19th day of April, 2024; and it is further

ORDERED that service of a copy of this Order to Show Cause and the papers upon which it is based ^{UPON all parties who have appeared and entitled to notice,} be made on or before April 16, 2024, by e-filing same shall be deemed good and sufficient service thereof.
