Dear Justice Merchan:

We respectfully submit this pre-motion letter seeking leave to file a motion to enforce a subpoena served on former Supervising Rackets Investigator Jeremy Rosenberg, in Brooklyn, New York, on March 18, 2024, and to compel the production of responsive documents. The subpoena is attached as Exhibit A. An affidavit of service is attached as Exhibit B. Email correspondence with Mr. Rosenberg following service of the subpoena is attached as Exhibit C. The subpoena was returnable on March 29, 2024. Rosenberg has not responded to the subpoena or filed a motion to quash.

This evidence is admissible to challenge the integrity of evidence DANY will seek to offer from Cohen's phones, for use in cross-examination of Cohen regarding the bias and hostility toward President Trump reflected in his | , and to attack the lack of integrity of DANY's investigation under federal constitutional cases such as Kyles v. Whitley, 514 U.S. 419, 447 & n.13 (1995).

President Trump is entitled to this specific evidence of bias, motive, and hostility under the state and federal constitutions, and the evidence is appropriately subject to a defense subpoena pursuant to CPL § 610.20(3).

Dear Justice Merchan:

We respectfully submit this pre-motion letter seeking leave to file a motion to enforce Requests 1 and 2 of a subpoena served on Stephanie Clifford in Brooklyn, New York on March 18, 2024, and to compel the production of responsive documents. The subpoena is attached as Exhibit A. An affidavit of service is attached as Exhibit B. As a courtesy, following service on Clifford, defense counsel emailed a copy of the subpoena to Clifford's attorney, Clark Brewster. In the email attached as Exhibit C, on March 20, 2024, Brewster claimed, inaccurately, that service had not been completed. The subpoena was returnable on March 29, 2024. Neither Brewster nor Clifford have responded to the subpoena or filed a motion to quash.

The subpoena is a valid demand for documents pursuant to CPL § 610.20(3). With the exception of subparagraph 1(p), Request 1 seeks records regarding the production, release, compensation, and related disclosures to the People regarding Clifford's "Stormy" documentary. Clifford's work with NBC Universal to monetize her status as a witness in this case, enhance the commercial success of the documentary, and prejudice potential jurors against President Trump by promoting and releasing the film just one week prior to the then-scheduled start of jury selection constitutes admissible evidence relating to bias, motive, and hostility under, *inter alia*, Rule 6.13 and *People v. Gissendanner*, 48 N.Y.2d 543 (1979). Although we do not agree that New York's Shield Law protects NBC Universal from making these disclosures, it certainly does not apply to Clifford.

Requests 1(p) and 2 seek communications between Clifford and witnesses Michael Cohen and Karen McDougal, see Rule 6.13, and potential hearsay declarants E. Jean Carroll, Jessica Leeds, and Natasha Stoynoff, see Rule 6.27. Communications between two fact witnesses, and confirmation that the communications were deleted, constitutes admissible evidence of bias and hostility arising from the strong inference that the witnesses communicated in order to coordinate their false testimony. Communications between Clifford and other women who have sought to monetize sexual assault claims against President Trump are probative of Clifford's motive and intent to do the same through false trial testimony. At minimum, we are entitled to two types of responsive materials concerning these requests. First, Clifford has communicated with Cohen regarding the allegations in this case, including in connection with her appearances on his podcast. Second, Kathy Griffin has stated publicly that she participates in multi-party electronic communications that include both Clifford and Carroll on a "daily" basis. President Trump is entitled to this specific evidence of bias, motive, and hostility under the state and federal constitutions, and the evidence is appropriately subject to a defense subpoena pursuant to CPL § 610.20(3)—particularly in light of public confirmation of some of the communications.
