Dear Chairman Rogers:

The enclosed package provides notification pursuant to Section 505 of the Consolidated Appropriations Act, 2024 (P.L. 118-42), as extended by the Full-Year Continuing Appropriations and Extensions Act, 2025 (P.L. 119-4) and the Continuing Appropriations, Agriculture, Legislative Branch, Military Construction and Veterans Affairs, and Extensions Act, 2026 (P.L. 119-37), of a reorganization of the Department of Justice (Department or DOJ).

The Department proposes a reorganization to establish a new National Fraud Enforcement Division as a new Departmental component led by an Assistant Attorney General (AAG) appointed by the President with advice and consent of the Senate. The National Fraud Enforcement Division, led by an AAG, will enforce the Federal criminal and civil laws against fraud targeting Federal government programs, Federally funded benefits, businesses, nonprofits, and private citizens nationwide. The new Division will oversee multi-district and multi-agency fraud investigations; provide advice, assistance, and direction to the United States Attorneys' Offices on fraud-related issues; and work closely with Federal agencies and Department components to identify, disrupt, and dismantle organized and sophisticated fraud schemes across jurisdictions. The Division will also help develop and set national enforcement priorities and propose legislative and regulatory reforms as necessary to close systematic vulnerabilities and prevent future abuses. In addition, the AAG heading up this new Division will advise the Attorney General and Deputy Attorney General on issues involving significant, high-impact fraud investigations and prosecutions and related policy matters.

The Department is required to have 11 AAGs who are appointed by the President with the advice and consent of the Senate (PAS). 28 U.S.C. § 506. Of the 11 PAS AAGs, only the AAG for National Security is given a specific portfolio by statute (28 U.S.C. § 507A), which includes

heading the National Security Division (NSD). Other than NSD, the Department is free to determine which components are headed by PAS AAGs. Following the elimination of the Tax Division, the Attorney General has discretion to assign the PAS AAG position currently assigned to that division to head up the newly created National Fraud Enforcement Division.

The Department expects to provide the National Fraud Enforcement Division with personnel and funding from within the Department's existing resources.

Copies of the current and proposed organizational charts for DOJ are attached.

The Office of Management and Budget does not object to transmittal of this notification.




