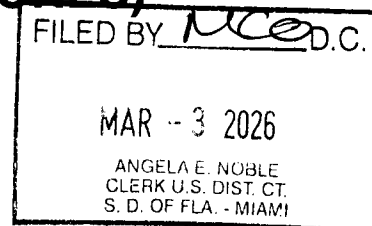

## EMERGENCY REQUEST FOR IMMEDIATE HUMANITARIAN RELEASE OR, IN THE ALTERNATIVE, A BOND HEARING

To the Honorable Court:

My name is **Arletty Pinero**, wife of **Adriel Ramon Mesa Rodriguez**. I respectfully request that the Court order my husband's **immediate humanitarian release**, or alternatively set an **expedited bond hearing**, due to his severe medical condition and the risk of deterioration while detained.

**Medical condition:** He suffers from **Crohn's disease, ulcerative colitis, and complex anorectal fistulas** with open draining wounds and recurrent infection, requiring strict hygiene, monitoring, and adequate medication. Detention conditions place him at high risk of worsening and complications.

**Family ties / humanitarian factors:** We have been together since **2014** and have been married since **2016** (legal effects recognized retroactively; see Exhibit B). I have a daughter whom he has helped raise since she was a baby—he has been her father figure for many years. I am ready to sponsor him, provide housing, and ensure he appears for all hearings and complies with any conditions of release.

**No danger / no flight risk:** He is not a danger to the community and has strong family ties and stability. He is committed to following all immigration and court requirements.

For these reasons, I respectfully ask the Court to grant **immediate release** or schedule an **urgent bond hearing** as soon as possible.

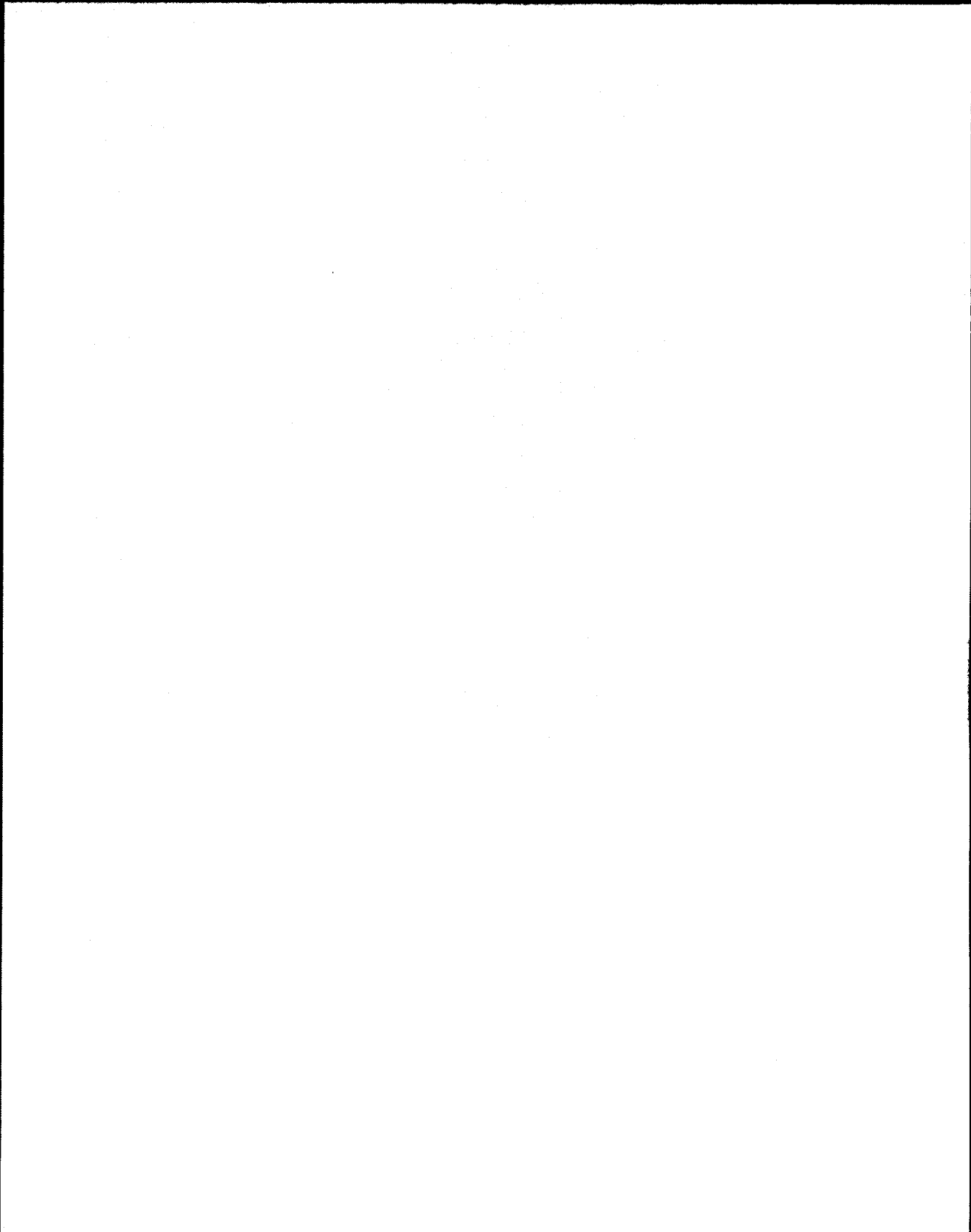

**Clinical History Summary:** Male patient with a personal pathological history of surgeries for anorectal abscesses and complex gluteal abscesses on more than three occasions, which later became complicated by a complex anorectal fistula. He reports anorectal pain and drainage of purulent material. On June 14, 2020, hospital admission was decided in order to perform a fistulotomy under spinal anesthesia. Local care of the surgical wound was provided for several months due to poor healing, and referral to Havana City was decided at the Hospital Hermanos Ameijeiras, where he received surgical treatment for anorectal fistulas.

In August 2021, the patient presented to emergency consultation due to colicky abdominal pain mainly in the right iliac fossa, diarrhea with mucus and bright red blood, and an urgent need to use the bathroom with involuntary passage of stool. He also reports continued perianal pain and the presence of multiple openings in the perianal region in a horseshoe pattern on each buttock with drainage of purulent material. Hospital admission was decided for study and treatment. As part of the studies, a colonoscopy was performed in which the characteristic lesions of inflammatory bowel disease were observed and described, and a biopsy was taken. The biopsy result indicated ulcerative colitis plus Crohn's disease. Treatment was initiated with limited resources; therefore, the patient has returned on multiple occasions to the hospital center because the specific medication for his disease is not available in the country.

#### **Diagnoses:**

- Acute exacerbated Crohn's disease
- Idiopathic ulcerative colitis
- Complex anorectal fistulas



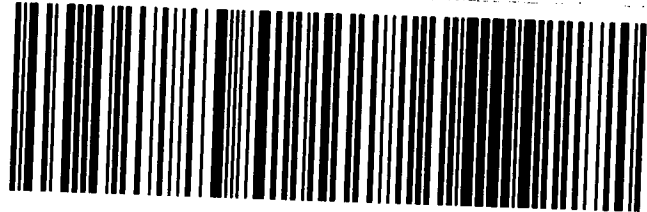
## **FAMILY SUPPORT**

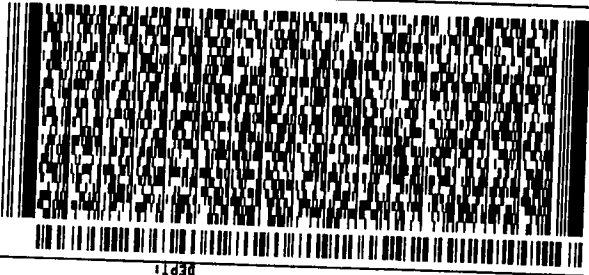
